





# SUPPLEMENTARY REGULATIONS

**1 AUTHORITY**: The Event will be held under the FIA International Sporting Code including Appendices and the National Competition Rules (NCR) CAMS. the Standing Regulations, Regulations relevant to the Event, The CAMS Motor Sport Passenger Ride Activity (MSPRA) Policy, the CAMS Come and Try Policy, these Supplementary Regulations and any Further Regulations or Bulletins which may be issued.

This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at <u>www.cams.com.au</u>.

Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the Event. Further details can be found in the CAMS Insurance Handbook, available at <u>www.cams.com.au</u>.

2 EVENT. The Event will be a Closed to Club Motorkhana and Come and Try Day. Day memberships will be available to allow any non-CCRMIT members to participate. A minimum of 4 and a maximum of 16 tests will be run on the day. The Event is Non-Competitive; timing will be recorded during the Event but no official results will be issued other than the boards on the day.

**3 PERMIT**. The Event will be held under CAMS Permit No **318/1706/07** which will be on display at the venue.

**6 VENUE**: The Event will be held on the 17<sup>th</sup> June at the Pakenham Auto Club Motorkhana Track – 405 McGregor Rd. Pakenham, Google ref. -38.106248, 145.467764. The Event will be conducted on a grass surface.

# 7 SCHEDULE:

Documentation & Scrutiny: 9:00am – 1:00pm

Driver's Briefing: 10:00am or after the Scrutiny of the car during the day

# The Event is expected to conclude by 4:00pm

8 **ENTRIES:** The Entry Fee for this Event will be <u>\$50</u>.

The Organiser reserves the right to refuse entry in accordance with NCR 83 of the current CAMS Manual. Entries open on publication of these regulations and close after 1:00pm on the day of the Event. The maximum number of entries for this Event will be 40. Up to FOUR drivers may compete in the same vehicle provided this is nominated on the Entry Form. Entries will be decided upon on order of receipt and eligibility.

**NOTE:** Drivers need a minimum Level 2 licence - Non Speed (L2NS) or Level 1 Come and Try Licence (which can be purchased on the day). Instructors will have a minimum L2NS licence.

Post completed Entry Form to the Event Secretary, 2/1494 High St, Glen Iris VIC 3146, or email (with proof of payment) to entries@ccrmit.com. An entry without proof of payment will not be accepted. Please pay via EFT to CCRMIT, BSB 063-150, Acc No. 10047474, reference <your surname>-MK. Cheques and Money Orders are to be made payable to Car Club RMIT Inc. Alternatively, payment can be made via cash on the day.

**9 DRIVERS BRIEFING:** Drivers Briefings will be given for Drivers before any Driver can commence track activity - this briefing will commence at the completion of the cars scrutineering.

### 10 VEHICLES:

a. <u>All</u> vehicles must comply with Schedule A and Group 4H of the current CAMS Manual.

b. <u>All</u> vehicles will undergo a safety check by CAMS Scrutineers prior to participation with an emphasis on brakes and seatbelts. Cars must also be free of loose items

c. Vehicles must be adequately muffled to comply with noise restrictions

d. Only road tyres will be allowed. Winter tread, hand-cut or Rally-type tyres of any sort will NOT be permitted.

e. Fuel must comply with Schedule G of the current CAMS Manual.

f. The Clerk of the Course will have the final say on whether or not a vehicle is deemed eligible to participate.

g. Per Schedule D – Apparel, adequate footwear must be worn by all drivers and passengers whilst competing—bare feet, thongs or sandals are not permitted; where no windscreen is fitted to a vehicle, drivers and passengers must wear adequate eye protection whilst competing

h. All passengers, including those who have signed an Entry Form, must sign the appropriate Passenger in Vehicle Indemnity Form.

## **10. PASS PASSENGERS AS INSTRUCTORS ONLY**

This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance

with the CAMS MSPRA Policy. Passengers are only allowed where their role is as an 'Instructor'.

- (a) A Briefing must be attended by each Driver and Passenger (and guardians of each Passenger if Passenger is under 18 years of age) conducted by the Clerk of the Course prior to the MSPRA commencing.
- (b) Instructors must:
  - i. Be experienced and have the permission of the Clerk of Course. The suitability of the Passenger is at the discretion of the Clerk of Course.
  - ii. Wear the same protective gear as a Driver in accordance with Schedule D of the current CAMS Manual of Motor Sport.
  - iii. Be fitted and restrained as required for each Automobile with consideration for their physical attributes.
  - iv. Complete a Passenger Ride Entry Form and disclaimer.
  - v. Drivers must fill out a Passenger Ride Entry Form to ride as a Passenger.
- (c) Vehicles and Apparel used must pass Scrutiny.
- (d) Vehicles shall only carry one Passenger at a time, unless otherwise approved by CAMS.
- **11 EXCLUSION**: Individuals behaving in a manner deemed to be inappropriate or prejudicial to the sport by the Clerk of the Course will be excluded from the Event.
- **12 ABANDONMENT**: The Organiser reserves the right to postpone, abandon or cancel the Event in accordance with NCR 59 of the current CAMS Manual.
- **13 INSURANCE:** Insurance for this Event will be provided in accordance with Appendix I of the current CAMS Manual. Public Risk Insurance is covered by the Permit, and Personal Accident Insurance is incorporated into the Licence fee.
- 14 **PROTESTS:** Any protests must be lodged in accordance with Part XII of the current CAMS Manual.
- **15** ALCOHOL, DRUGS AND OTHER SUBSTANCES: Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

#### RISK WARNING AND ASSUMPTION OF RISK

Motor Sport Activities are inherently dangerous recreational activities and there is significant risk of injury, disability or death.

If you do not wish to be exposed to such risks, then you should not participate in Motor Sport Activities.

I acknowledge that:

- the risks associated with attending or participating in Motor Sport Activities include but are not limited to the risk that I may suffer harm as a result of:
  - o motor vehicles (or parts of them) colliding with other motor vehicles or persons or property;
    - o others participants acting dangerously or with lack of skills;
    - high levels of noise exposure;
    - acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in the Event; and
    - o the failure or unsuitability of facilities (including grand-stands, fences and guard rails) to ensure my safety.

#### EXCLUSION OF LIABILITY, RELEASE & INDEMNITY

In exchange for being able to attend or participate in Motor Sport Activities, I agree:

- to release CAMS and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:
  my death;
  - o any physical or mental injury (including the aggravation, acceleration or recurrence of such an injury);
  - the contraction, aggravation or acceleration of a disease;
  - the coming into existence, the aggravation, acceleration or recurrence of any othercondition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs:
  - o that is or may be harmful or disadvantageous to me or the community; or
  - $\circ$   $\quad$  that may result in harm or disadvantage to me or the community,

howsoever arising from my participation in or attendance at the Motor Sport Activities;

- to indemnify and hold harmless and keep indemnified CAMS and the Entities to the maximum extent permitted by law in respect of any Claim by any person;
- to be bound to the rules, regulations and policies of the Entities; and
- to attend at or participate in the Motor Sport Activities at my own risk.

#### I understand that:

- nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is caused by the Reckless Conduct of CAMS and the Entities as the supplier of Motor Sport Activities / Recreational Services;
- nothing in this document prEvents the Entities from relying on any laws (including statute and common law) that limit or preclude their liability;
- nothing in this document excludes any term or guarantee which under statute cannot be excluded; however the liability of the Entities is limited to the minimum liability allowable by law;
- nothing in this document precludes me from making a claim under a CAMS insurance policy where I am expressly entitled to make a claim under that insurance policy; and
- CAMS has arranged some limited personal injury insurance coverage which may provide me with some protection for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities. However, I acknowledge and accept that the insurance taken out by CAMS may not provide me with full indemnity for loss, damage or injury that I may suffer during my participation in the Motor Sport Activities, and that I may have to pay the excess if a Claim is made under an insurance policy on my behalf. I agree that my own insurance arrangements are ultimately my responsibility and I will arrange any additional coverage at my expense after taking into account CAMS insurance arrangements, this document and my own circumstances.

Where Motor Sport Activities are held in the following jurisdictions, I acknowledge that I have also read and accept the following warnings:

#### WARNING APPLICABLE IN RELATION TO MOTOR SPORT ACTIVITIES HELD IN VICTORIA

#### WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012:

Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to you:

- are rendered with due care and skill;
- are reasonably fit for any purpose which you either expressly or by implication, make known to the supplier; and

might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22 of the Australian Consumer Law and Fair Trading Act 2012 (Vic), the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Australian Consumer Law and Fair Trading Act 2012 if you are killed or injured because the services were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in this form.

'Reckless Conduct' means conduct where the supplier of the recreational services is aware, or should reasonably have been aware, of a significant risk that the conduct could result in personal injury to another person and engages in the conduct despite the risk and without adequate justification;

f. 'Recreational Services' means (unless otherwise defined in this document) services that consist of participation in:

a) a sporting activity; or

- b) a similar leisure time pursuit or any other activity that:
- (i) involves a significant degree of physical exertion or physical risk; and
- (ii) is undertaken for the purposes of recreation, enjoyment or leisure.
